LEGAL & GOVERNMENT AFFAIRS: MAA CONTINUED ITS WORK IN THE LEGAL SPHERE BY JOINING FORCES WITH OTHER LGBT ADVOCATES TO FILE MULTIPLE LAWSUITS RANGING FROM TRANSGENDER SERVICE MEMBERS RIGHTS TO PREVENTING INDIVIDUALS LIVING WITH HIV FROM BEING DISCHARGED FROM THE MILITARY. MAA CONTINUED PROVIDING FREE LEGAL COUNSELING TO SERVICE MEMBERS WITH LEGAL ISSUES STEMMING FROM DISCRIMINATION ON ONE'S PERCEIVED OR ACTUAL SEXUAL ORIENTATION OR GENDER IDENTITY INCLUDING HIV POSITIVE AND TRANSGENDER SERVICE CASES. IN ADDITION, MAA CONTINUED PROVIDING ASSISTANCE TO VETERANS SEEKING TO UPGRADE OR CORRECT THEIR DISCHARGE PAPERWORK, AND CONTINUED TO WORK WITH ELECTED OFFICIALS AND FEDERAL AGENCIES IN DEVELOPING LEGISLATIVE LANGUAGE THAT WOULD BENEFIT THE LIVES OF ITS CONSTITUENTS.

COMMUNICATIONS: IN 2021, MAA CONTINUED THE WORK OF ITS PREDECESSOR ORGANIZATIONS BY SHARING STORIES IN THE MEDIA OF LGBT MILITARY FAMILIES. MAA JOINED NATIONAL AND REGIONAL CONVERSATIONS AND PUBLIC FORUMS ABOUT THE EXPERIENCES OF LGBT SERVICE MEMBERS IN THE POST-DADT ERA AND CONTINUED TO ADVOCATE FOR AUTHENTIC TRANSGENDER SERVICE. THE ORGANIZATION EDUCATED LGBT SERVICEMEMBERS AND VETERANS ABOUT THEIR RIGHT TO SERVE AND TO CORRECT NEGATIVE DISCHARGE/DISCIPLINE RELATED TO LGBT STATUS. MAA MANAGED A STRONG SOCIAL MEDIA PRESENCE WITH OVER 70,000 FOLLOWERS. THE ORGANIZATION ALSO WORKED TO EDUCATE PUBLIC OFFICIALS AT ALL LEVELS OF GOVERNMENTS ON EFFORTS THEY COULD TAKE TO HELP PROTECT THE RIGHTS OF THE LGBT SERVICE MEMBER COMMUNITY. THE ORGANIZATION ALSO CONTINUED TO PUBLISH ITS QUARTERLY MAGAZINES AND MONTHLY NEWSLETTERS.

MEMBER SERVICES: MAA SUPPORTS ITS MEMBERS AND THEIR FAMILIES THROUGH PARTICIPATION IN NATIONAL AND REGIONAL PRIDE EVENTS. AS A RESULT OF THE MERGER, MAA TOOK ON SERVICES DIRECTLY RELATED TO FAMILIES AND CHILDREN DEPENDENTS PER THE MERGER, MAA TOOK ON RESPONSIBILITY OF THE MILPRIDE PROGRAM, WHICH IS DESIGNED TO BE A RESOURCE AND SUPPORT NETWORK HELPING THESE MODERN MILITARY FAMILIES NAVIGATE THE UNIQUE CHALLENGES OF MILITARY SERVICE. ADDITIONALLY, MAA PROVIDED A SUPPORT NETWORK FOR FAMILIES AS THEY PCS TO NEW INSTALLATIONS. ONE SCHOLARSHIP OF \$5,000 WAS GRANTED IN 2021, AS WERE FIFTY, \$100 GIFT CARDS AS A MILITARY FAMILY HOLIDAY INITIATIVE.

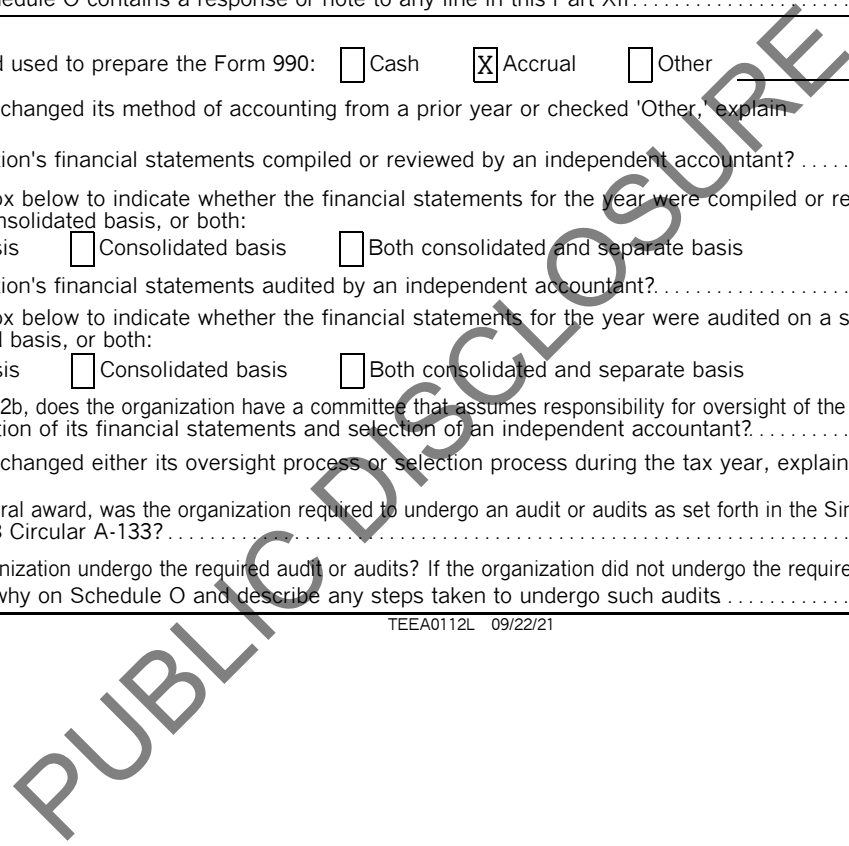

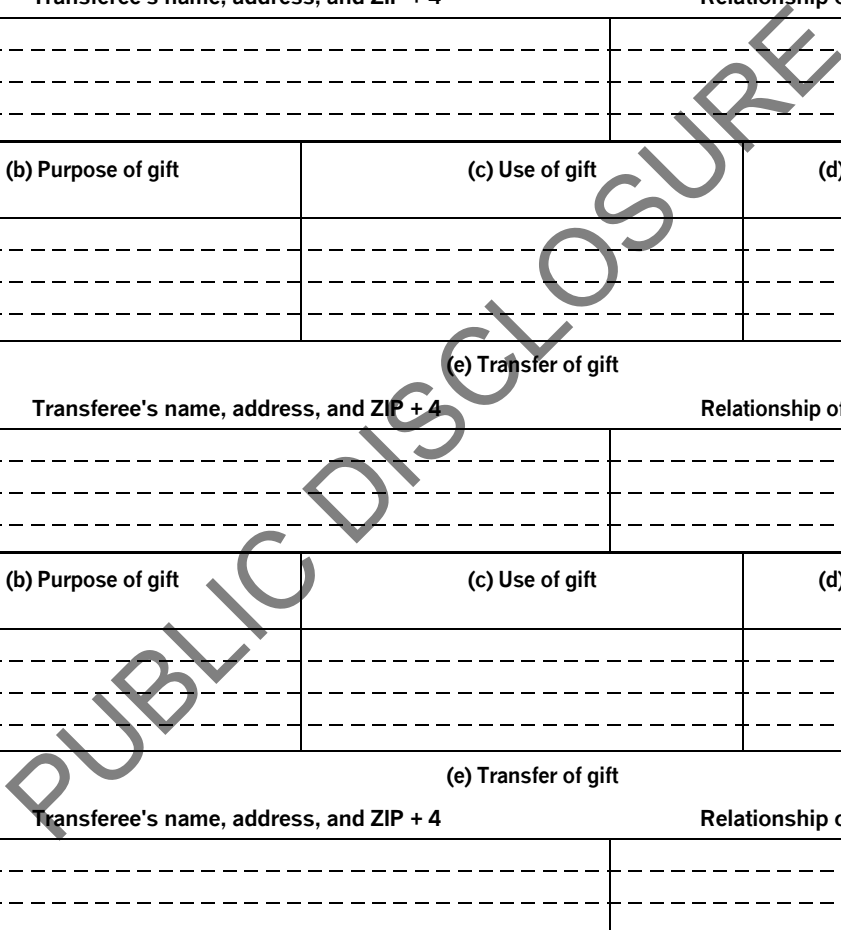

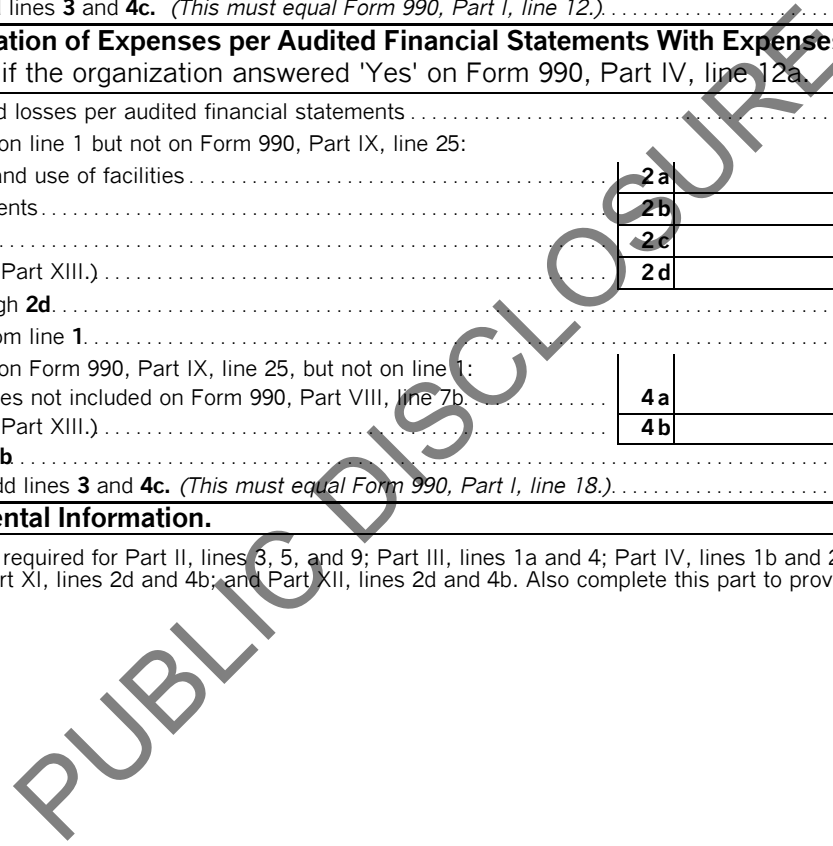
